7:10 FEBRUARY 2017 FINANCIAL REPORTS: Tracey Fiereck

Dr. Mustafa Ibrahim presented a report from the expansion committee. The STEP K-5 school has 54 students enrolled. About 50 applications have been picked up by parents. It is expected to have one class per grade level and a wait list if necessary. Current enrollment is good and the numbers are increasing. Preview kits have been ordered for elementary school curriculum. A group of teachers went to visit St. Croix Prep and were able to learn about their structure and curriculum. It was a very beneficial visit. ACCESS tests for ELL students will be completed tomorrow. The ACT test was given to 11th graders yesterday. STEP has hired two teachers for the elementary school and we are continuing to recruit and interview other teachers.
